NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS :


1. The name of the Trust shall be Raja Chandrachur Deva Educational Trust hereinafter referred to as the Trust.
2. The Office of the Trust shall be situated at village- Ulao, Ward No.- 3, Ps.- Muffasil, District-Begusarai and the address may be changed as and when found necessary by the Trustees.

3. TRUSTEES

(a) The first Trustees shall be :

- (i) I, Dr. Manish Deva, S/o.- Sri Manhar Deva, aged 43 years, resident of village - Uloa, Ward No.- 3, Ps.- Muffasil, (Singhaul O.P.), District-Begusarai.
- (ii) Shilakant Manbansh, S/o.- Sri Bibhuti Bhushan Manbansh aged-45 years, resident of Mohalla- Eas Kapasia, Ward.- 13, Ps.- Muffasil, (Singhaul O.P.), District-Begusarai.
- (iii) Chandra Prakash Mahton Chandu, S/o.- Sri Ram Nandan Mahton, aged - 37 years, resident of village - Makardahi, Ps.- Muffasil, District- Begusarai.
- (iv) Rajesh Kumar Sah, S/o.- Sri Harinandan Sah aged 42 years, Behind Alka Cinema, Po.- Refinery Township, Ps.- Town, Dist.-Begusarai

- (b) Dr. Manish Deva shall be the managing Trustee and Sri Shilakant  
Manbansh the Joint Managing Trustee and both shall hold office  
for life or till voluntarily retirement or resignation

In the event of the office of the Managing Trustee become vacant,  
the joint Managing Trustee will take over as the Managing Trustee.  
In the event of office of Joint Managing Trustee becoming vacant,  
remaining Trustees may co-opt any of them as Joint Managing  
Trustee.

- (c) The other Trustees shall retire by rotation in one at a time, the first  
to commence three years from the date of the Trust Deed. The  
retiring Trustee will be eligible to be co-opted for further periods.

- (d) The Managing Trustee and Joint Managing Trustee shall at their  
discretion Co.-opt. any person/persons who may be helpful in  
achieving the objects of the Trust as a Trustee.


- (e) The Maximum member of Trustee shall not exceed eight.

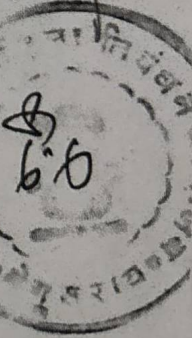

- (b) To make provisions to advance the cause of, and impart Nursery, Primary, Secondary, Higher, Commercial Industrial, Technical, Physical and all the any other type or kind of education.
- (c) To establish, maintain, take over Management administer or run any institutions, colleges engaged in the imparting of education to students upto any level that may be found necessary and/or desirable.
- (d) To generally impart education to children and for the purpose to do all acts that may be necessary.
- (e) To establish, run, manage, administer any institution or college or school to train persons to be teachers who will impart education to children and/or student in school, colleges and other similar institutions.
- (f) To promote adult education.
- (g) To hold, arrange and organizes meetings, lectures, talks discussions, seminars, symposia, conferences, competitions researches and study visits, tours, excursions, exhibitions debates, Cinema, Audio-Visual programme, the artistic performances and other cultural activities, sports and games.
- (h) To establish, maintenance and support of libraries, museums and reading rooms and distribution of books etc., for advancement of education and knowledge in general.
- (i) To provide and meet all expenses of the school knowledge in general.

(j) Advancement and propagation of education and leaning including establishment, maintenance and support of schools, colleges, Pathshalas and other educational institutions, auditoriums, professor ship, lecturership, scholarship and prozes etc.

(k) Advancement of any other object of general public utility and relief like conducting seminars on educational advancement providing necessary assistance during natural calamities and such other assistance as may be required from time to time.

## 5. MANAGEMENT

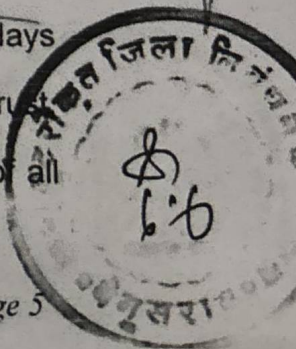
(a) The Management, contraol of the property and affairs of the Trust aforesaid shall be vested in the Trustees with full powers and authority to purchase or hold any land or hereditament and construct any building for the object of the Trust or any fund or any other properties or investment at any time subject to the Trust of these presents. It shall be lawful for the Trustees from time to time to frame such rules and regulations for the management such rules and regulations for the management and administration of the Trust and charities as they deem fit and to alter and vary the same from time to make new rules and regulations shall be inconsistent with the provisions of section2(15), 11, 13 and 80-G of the Income Tax Act. 1961.

(b) The Trustees shall meet as often as possible but not less than 4 times in a year and there shall be the maximum interval of 90 days between the two such meeting for efficient mangement of the Tru to consider the income and expenditure and for disposing of all

- (c) At all the meetings of the Trustees, three members shall form quorum.
- (d) At all meetings of Trustee, the Managing Trustee or in his absence Joint Managing Trustee or in Chairman and all decisions of the Trustee shall be the chairman and all decisions of the Trustee shall be by majority vote and the Chairman shall have a casting vote in case of equality of votes.
- (e) All proceeding of the meeting of Trustees shall be recorded in a Minutes Book kept for the purpose.
- (f) Trustees who fail to attend three consecutive meeting without prior intimation or information shall cease to be Trustees, unless otherwise majority of the remaining Trustee accord him exception on genuine and good grounds.
- (g) In case of any difference of opinion between the trustees in any matter connected to the Trust and its administration the decision of the majority shall be final and binding on all the Trustees.

6. POWERS OF TRUSTEES :

- (a) To Manage Trust Funds and collect and recover the interest, income and profits thereof and to pay thereout the expenses of collection and other outgoing if any.
- (b) The Trustee shall have all powers specifically conferred to do things as may be required for the proper conduct of the Trust and in the interest of the Trust, whenever, such power are not specifically conferred.

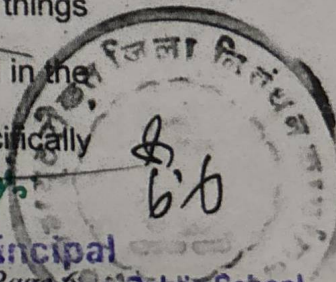

- (c) The Trustees shall be entitled from time to time to open, maintain and operate a Bank account or account in the name of the Trust or in the name of the School or schools or Institutions at such Bank or Banks as they may from time to time decide and may at any time pay or cause to be paid any amount forming part of the Trust Fund/School Fund or the income thereof to the credit of any such account or accounts either by way of fixed or current Accounts or any other accounts. Any such account shall be operated open individually by the Managing Trustee or the Joint Managing Trustee or by any two of other Trustees.
- (d) The Trustees shall have power to maintain and deferred all such suits and take such other steps as may be reasonable and requisite for the preservation of the Trust Property and the protection of the title thereof. At the discretion of the Trustees, the Managing Trustee, the Joint Managing Trustee or any other Trustee or Trustee or such authorised persons or persons shall represent in all such proceedings.
- (e) The Trustees are bound by all the duties and liabilities cast upon them under Chapter-III, Section 11 to 30 of the Indian Trust Act 1882 except to the extent of the powers specifically conferred under these presents.
- (f) The Trustees at their discretion may sell any immovable or movable property or properties which may for the time being the subject of the Trust of these present, with power to buy and sell the same without being responsible for any loss that may thereby be incurred and in case of such sale, to execute and do all such deeds

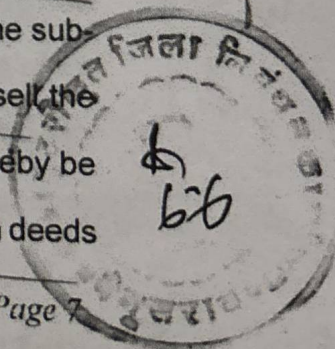

7. The Trust can be dissolved if the objectives of the Trust has been fully achieved or the possibility of achieving the objectives there of has become so remote and extict that the Trustees consider it proper to dissolve the Trust.

In the event of dissolution of winding up of the Trust the assets remaining on dissolution shall be transferred to another Trust, Society or Institution where objects are similar to there of this Trust and that in no event shall assets so remaining be distributed among the Trustees.

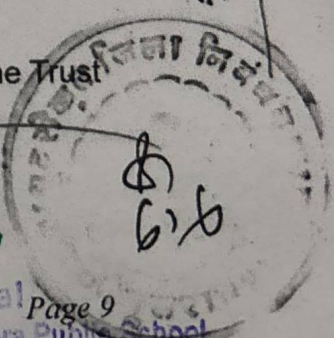
